


**ADMINISTRATIVE ORDER NO. 2018-08**  
**22<sup>nd</sup> JUDICIAL CIRCUIT**  
**McHENRY COUNTY, ILLINOIS**

IT IS HEREBY ORDERED that effective April 16, 2018, Administrative Order 2017-05 is vacated; and, further, IT IS HEREBY ORDERED that the following Committees of the 22<sup>nd</sup> Judicial Circuit are established. The Chief Judge shall be an ex-officio member of each Committee and shall receive notice (and minutes if prepared) of all meetings. The chairperson of each Committee may, (1) request that the Chief Judge add judicial or non-judicial members to a committee on a permanent basis; (2) request that the Chief Judge add judicial or non-judicial members to a committee on a temporary basis to deal with particular questions or problems, and (3) appoint subcommittees.

Each committee has been designated as “Standing” or “Ad hoc”. Standing Committees shall hold a minimum of two meetings each calendar year. Ad hoc Committees shall meet on an as needed basis with no minimum number of meetings each calendar year, but at the call of the Chair of the committee or the call of the Chief Judge.
